

COVID-19 Response Fund Rubric

Given the large-scale impact of the crisis, the Foundation is using the following rubric to assess and prioritize emergency grant inquiries from nonprofits to recover from lost revenue and to respond to new and emerging needs of vulnerable populations. **Some organizations will be required to provide funding scenarios that keep the organization viable but may require significant scaling back of staff and programming.** Requests that score higher on the rubric could be considered for higher levels of support that allow the organization to maintain key staff and programming. Requests that score lower may still be eligible for funding but at a lower level of support. Please fill out the attached [application](#) to start the process of requesting support from the COVID-19 Response Fund. A single [application](#) is being used to assess grant requests, lines of credit and immediate capacity building support. Please consider the full range of your organization’s needs when responding. If your [application](#) is accepted, there will be minimal further documentation required, particularly for organizations that have received a grant from the Foundation in the past 24 months. We will respond to [applications](#) as quickly as possible. Grant amounts vary and will be based on the budget size of the organization and the community need being addressed.
